# Perinatal mental healthcare: Tertiary outpatient care option

**Waypoint Outpatient Assessment and Treatment Services** 

Waypoint Centre for Mental Health Care has psychiatry expertise to support individuals in the perinatal period within their Outpatient Assessment and Treatment Services (OATS).

#### **Program Description**

OATS offers a time-limited, goal-directed service for people experiencing moderate to severe mental health challenges. Psychiatric consultations and treatment as well as group interventions and individual counselling are offered. Some services are offered virtually. Clients can expect to be seen by a psychiatrist up to 6 months and interdisciplinary treatment concluded by 9 months.

#### **Referral Requirements**

- Must have documented evidence of current psychiatric symptoms for which a treatment has been offered and shown to be unsuccessful and/or treatment recommendations and diagnostic clarification are being sought.
- A comprehensive summary of treatment of current psychiatric symptoms and copies of previous psychiatric consultations (if available)
- · Details of comorbid physical health issues
- A comprehensive current medication list including a list of all medications that have be trialed

#### **Inclusion Criteria**

- Clients 16 years and over requiring psychiatric management in an inter-disciplinary environment (e.g. diagnostic clarification, treatment planning, treatment optimization)
- Clients care needs cannot be met in the community

#### **Exclusion Criteria**

- Treatment needs can be met through the Primary Care Provider (PCP) and other community services (e.g. prescribing, injection administration, counselling)
- Request is only for case management or medication administration
- If the sole purpose of the referral is mandated by the criminal justice system
- If the sole purpose of the referral is for third party assessments (e.g. parenting assessments, insurance, driving)
- Requests for experimental treatments (e.g. medical cannabis, LSD, Ketamine)

#### **Admission and Discharge Planning**


- Referrals will be reviewed and accepted by Central Intake onto the OATS Waitlist
- Referrals will be triaged for priority based on clinical risk (It is important that pregnancy or post-partum is noted on the referral to assist with triaging. The perinatal period is triaged as high priority)
- Discharges will done in collaboration with PCP and pathways for re-access will be available


### **Health Stats Simcoe Muskoka**
